*Golf Canada Rules of Golf (effective January 2023) and the Golf Nova Scotia 2023 Local Rules and Terms of the Competition, the following Supplementary Local Rules and any daily amendments published govern play. **NOTE: Local rules published by the Host Club will NOT apply. The penalty for breach of a Local Rule is 2 strokes in Stroke Play and may result in disqualification for any subsequent offence.***

*Players are reminded that conduct considered detrimental to the best interests of the game or unbecoming a competitor, either on or off the course, and coming to the attention of the Tournament Committee, will be strictly dealt with and **may result in disqualification** of the offending person(s).*

1. **TEES:** The championship will be contested from the WHITE tee. Players 65 years of age and older may elect to play from the forward YELLOW tees.
2. **COURSE YARDAGE MARKERS:** Measured to the center of the greens: Blue-200; White-150, Red-100 – posts are movable obstructions.
3. **HOLE LOCATIONS:** Pin sheets will be provided at the first tee.
4. **DESIGNATED PRACTICE AREAS:** Driving Range and Practice greens. See Golf Nova Scotia 2023 Local Rules & Terms of the Competition No.8 (a and b). **PRACTICING BETWEEN HOLES IS PROHIBITED AND SUBJECT TO PENALTY.**
5. **OUT OF BOUNDS:** Defined by telephone polls on left side of #1
White stakes and boundary fence on #2 and #3
Trees, fence and white stakes on #10
White stakes on #13
6. **PENALTY AREAS:** Defined by yellow stakes and/or by on holes # 1, 4, 14 & 17
Defined by red stakes and/or lines on holes # 1, 4, 5, 6, 10, 12, 14, 15, 17 & 18
7. **ABNORMAL COURSE CONDITIONS:** See Golf Nova Scotia Local Rules & Terms of the Competition
Worn-out areas adjacent or on extension to cart paths are considered an extension of the cart path. Free Relief is available under Rule 16.1.

Left side of #7 green – area with dotted white line. If a player's ball is on the putting green and there is interference by the GUR, the player may take free relief by placing the original ball or another ball on the nearest point of complete relief (Rule 16.1d). Interference exists when the player's ball touches or is in the GUR or interferes with the area of intended stance. The ball must be on the putting green for free relief from line-of-play interference (Rule 16.1a).

8. **PACE OF PLAY:** Pace of play will be strictly applied. The scorecard will indicate the time par for each hole. All competitors are expected to complete their rounds within the time allotted. Penalty structure for breach of Rule 5.6b will be: first breach: a warning; second breach 1 stroke penalty; third breach general penalty.
9. **BREAKING TIES:** If two (2) or more teams are tied for the Overall Championship a sudden-death playoff will be used to determine the winner. The playoff will commence at Paragon on #1 and #9 and repeat, as necessary, until a winner is decided. All other ties will remain as ties and prizing will be awarded accordingly.
